#### ERIN TRISH, PhD



**Erin Trish, PhD**, is co-director of the USC Schaeffer Center for Health Policy & Economics and an associate professor of pharmaceutical and health economics at the USC Mann School of Pharmacy and Pharmaceutical Sciences. She is a nonresident fellow in economic studies at the Brookings Institution. Trish's research focuses on the intersection of public policy and health care markets, with recent projects on Medicare Part D, Medicare Advantage, surprise medical bills, health care market concentrations and health care reform. Trish completed a postdoctoral fellowship at the USC Schaeffer Center and the Fielding School of Public Health at UCLA. She earned a PhD in health policy and economics from the Johns Hopkins Bloomberg School of Public Health and a BS in biomedical engineering from Johns Hopkins University.

#### JOE AVELINO, FACHE



**Joe Avelino** is CEO of College Medical Center, Long Beach. He has an extensive background in hospital operations, business development, revenue cycle and regulatory compliance. Avelino began his health care career as an ER and neurosurgery critical care nurse. He served over 25 years with the U.S. Army, coordinating medical care for injured soldiers returning from the Middle East and earning several medals. The immediate past chair of HASC's executive board, Avelino is vice president of the United Hospital Association board. He received his BS in nursing from American University and his master's in health services administration from George Washington University.

#### PRECIOUS MAYES



**Precious Mayes** has served since 2018 as president and CEO of Pacifica Hospital of the Valley, one of the state's most well-respected safety net hospitals. With over 25 years of executive experience, she represents California safety net hospitals with state and federal agencies. Mayes also advocates for hospitals on multiple initiatives with elected officials, including helping pass a bill extending seismic compliance for Pacifica. During the pandemic, she led efforts with the state to implement four new medical and mental health programs. In 2019, Mayes received a congressional award from Rep. Tony Cárdenas (CA-029) for her years of outstanding community service, advocacy and leadership.

#### JOHN CHAPMAN, FACHE



**John T. Chapman, FACHE**, is president and CEO at San Antonio Regional Hospital, Upland. A microbiologist by training, he has been a hospital executive for over 20 years and represents the Inland Empire on the HASC board. Prior to joining San Antonio in 2018, Chapman was chief operations officer at Highland Hospital, Oakland. Along with overseeing Highland's operations, he led clinical and support services for Alameda Health System. Earlier, Chapman held roles including executive director of clinical services and director of laboratory services at UCSF Medical Center. He holds a BS in microbiology and immunology from UC Berkeley and an MBA in health care management from University of Phoenix.
