Whether carrying cargo and personnel into enemy territory or travelers to Paris, every single flight has required absolute trust between him and his crew. It's a lesson that's been reinforced mission after mission, flight after flight: Trust your people like your life depends upon it.

But Lt. Col. Harris doesn't just understand the importance of trust. He knows how to build it through a culture of deep

commitment, accountability and empowerment. As an Air Force Academy squadron commander and instructor, he discovered the principles behind the trust he experienced in the cockpit. Former professional motocross champion **Aaron Baker** is a recovering quadriplegic. He is also a husband and father, and an author, orator, adventure athlete, entrepreneur and ambassador for spinal cord injury. In 1999, Baker suffered a broken neck in a horrific motocross accident. Since the onset of his injury, his focus has been rebuilding, mindfully and intentionally, with clear purpose and a grateful heart. Baker credits more than two decades of recovery and his simple, yet full and peaceful, life today to consistent, long-term restorative movement and mindset. For more than 20 years, he has been sharing his story with audiences around the world. Baker empowers audiences to think and move through adversity — and the cycles of life — with mind, body, spirit and lifestyle choices, and to discover peace, power, joy and reverence for life.
